**RESOLUTION APPROVING THE ANNUAL BUDGET OF

WHEREAS, the Sangguniang Panlungsod or Sangguniang Bayan is empowered to review all barangay ordinances authorizing annual appropriations as mandated in Chapter III, Article 2, Section III of the Local Government Code of 1991;

WHEREAS, the Committee on Appropriations conducted a thorough and wholistic evaluation of the proposed Barangay Annual Budget of Barangay Tanza for CY 2020;

WHEREAS, the proposed Barangay Annual Budget of Barangay Tanza for CY 2020 is in order and has complied with the established budgetary requirements as certified by the Local Finance Committee and the same was validated by the Committee on Appropriations;

WHEREAS, the Barangay Officials shall allocate funds from their respective Barangay Disaster Risk Reduction and Management Fund (BDRRMF) for the planting of bamboo propagules along the coastal areas/River Banks in the Barangay, Cagayan River and Pinacanauan River and to further coordinate with the CENRO Head, Atty. 
