RESOLUTION APPROVING THE SANGGUNIANG KABATAAN (SK) ANNUAL BUDGET OF BARANGAY BUNTUN FOR CY 2020

WHEREAS, the Sangguniang Panlungsod or Sangguniang Bayan is empowered to review all barangay ordinances authorizing annual appropriations as mandated in Chapter III, Article 2, Section III of the Local Government Code of 1991;

WHEREAS, the Committee on Appropriations has conducted a thorough and wholistic evaluation of the proposed Sangguniang Kabataaan (SK) Annual Budget of Barangay Buntun for CY 2020;

WHEREAS, the proposed Sangguniang Kabataan (SK) Annual Budget of Barangay Buntun for CY 2020 is in order and has complied with the established budgetary requirements as certified by the Local Finance Committee and the same was validated by the Committee on Appropriations.

WHEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the Sangguniang Kabataan (SK) Annual Budget for Calendar Year 2020 of Barangay Buntun in the amount of P512,801.60 prepared in consistent with the approved Annual Barangay Youth Investment Program (ABYIP).

RESOLVED FURTHER, that in view of the issuance of Department of Budget and Management (DBM), Department of the Interior and Local Government (DILG) and National Youth Commission (NYC) Joint Memorandum Circular (JMC) No. 1, s. 2019 dated January 23, 2019, Re: Guidelines on the Appropriation, Release, Planning and Budgeting Process for the SK Funds, the committee further recommends that no disbursement of funds shall be made until such time the Barangay SK Treasurer is duly appointed and the corresponding Annual Barangay Youth Investment Program (ABYIP), SK Annual Budget and the corresponding Programs of Work are submitted.

On motion of Hon. Raymund P. Guzman, duly seconded by Hon. Arnel T. Arugay and without any objection, CITY RESOLUTION NO. 065-08-2020 was APPROVED under suspended rules.
