WHEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Sangguniang Kabataan (SK) Annual Budget for Calendar Year 2020 of Barangay Gosi Norte in the amount of P222,500.00 prepared in consistent with the approved Annual Barangay Youth Investment Program (ABYIP).


