**RESOLUTION EXPRESSING SINCERE COMMENDATION TO HONORABLE RAYMOND REYNOLD R. LAUGAN FOR HAVING BEEN APPOINTED AS ASSOCIATE JUSTICE OF THE COURT OF APPEALS OF THE PHILIPPINES**

**WHEREAS**, President Rodrigo Roa Duterte appointed **Honorable Raymond Reynold R. Lauigan** as an Associate Justice of the Court of Appeals, on March 3, 2020;

**WHEREAS**, prior to his appointment, **Honorable Raymond Reynold R. Lauigan** has been the Presiding Judge of Regional Trial Court Branch 1 since 2012 and the Executive Judge of Regional Trial Court, Tuguegarao City, Cagayan, where he was distinguished for his speedy disposition of cases;

**WHEREAS**, for the past five years, **Justice Raymond Reynold R. Lauigan** was able to efficiently dispose 1,674 cases with an equivalent disposal rate of 91.89% and all his active cases were below five (5) years of age;

**WHEREAS**, prior to becoming a judge, **Justice Raymond Reynold R. Lauigan** served as President of the Integrated Bar of the Philippines-Cagayan Chapter and a Public Attorney's Office (PAO) lawyer for almost two (2) years;

**WHEREAS**, the Judiciary, through the Society for Judicial Excellence (SJE), honored Justice Raymond Reynold R. Lauigan as the "*Chief Justice Ramon Avanceña Awardee*" during the 28<sup>th</sup> awarding ceremonies for the 2019 Search for Outstanding Judges and Clerks of Court held on October 4, 2019 at the Rigodon Hall, Manila Hotel;

**WHEREAS**, **Justice Raymond Reynold R. Lauigan** has also received the Dangal ng Bayan Award by the Civil Service Commission Regional Office No. 02 and an award for "Exemplary Dedication and Incorruptible Performance of Duty as a Judge" by the Philippine Drug Enforcement Agency. He was also a member of the Technical Working Group (TWG) that drafted the Philippine Revised Rules of Civil Procedure;

**WHEREAS**, **Justice Raymond Reynold R. Lauigan** hails from Tuguegarao City and finished his elementary education at North Central Elementary School, now Tuguegarao North Central School in 1981 and secondary education at Cagayan National High School in 1985, both as class valedictorian;

**WHEREAS**, the City Government of Tuguegarao commends **Justice Raymond Reynold R. Lauigan** for his outstanding contribution and achievement bringing pride, respect and honor to his family and to the people of Tuguegarao.


**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to express sincere commendation to **Honorable Raymond Reynold R. Lauigan** for having been appointed as Associate Justice of the Court of Appeals of the Philippines.




