WHEREAS, the proposed Sangguniang Kabataan (SK) Annual Budget of Barangay Namabbalan Norte for CY 2020 is in order and has complied with the established budgetary requirements as certified by the Local Finance Committee and the same was validated by the Committee on Appropriations.




On motion of Hon. Karen L. Taguinod, **CITY RESOLUTION NO. 091-08-2020** was **APPROVED** under suspended rules.


