**RESOLUTION ADOPTING AND APPROVING LGU-P4 SELECTION COMMITTEE  
 RESOLUTION NO. 1 TITLED “RESOLUTION IDENTIFYING THE LOCAL GOVERNMENT  
 UNIT (PGU-P4) PROJECTS OF THE LGU-TUGUEGARAO CITY PUBLIC-PRIVATE  
 PARTNERSHIP PROJECTS”**

**WHEREAS**, Section 9 of City Ordinance No. 052-2017 titled “*Tuguegarao City Code Pursuing a Public Private Partnership for the People Initiative for Local Government Unit (LGU-P4) Approach Towards Development, Providing for the Procedure for Selecting the Private Sector Proponent, Adopting a Contract Management Framework, and Providing Appropriations for Other Purposes*” states among others that the City Mayor shall identify the viable Public-Private Partnership Projects of the Tuguegarao City Government;

**WHEREAS**, on February 13, 2020, the Local Government Unit of Tuguegarao City (LGU-P4) Selection Committee convened and passed Resolution No. 01-2020 titled “*Resolution Identifying the Local Government Unit (LGU-P4) Projects of the LGU-Tuguegarao City Public-Private Partnership Projects;*”

**WHEREAS**, the following viable Public-Private Partnership Projects were endorsed to the 8<sup>th</sup> City Council:

1. Convention Center
2. Central Terminal for Land Transportation
3. Agro-Forest Economic Tourism Park
4. I.T. Park Development
5. International Airport
6. Establishment of large scale bamboo plant and processing plant
7. Establishment of hazardous and toxic wastes treatment and disposal facility such as, but not limited to, Septage Treatment Plant, Water Treatment Plant, Sewerage Treatment Plant, and Treatment, Storage and Disposal Facility

8. Garbage collection/Solid Waste Management
9. Radio Station
10. Dressing plant, slaughterhouse/modern abattoir with cold storage and meat van
11. Post harvest facilities with SSF like rice, corn and vegetable dryer/s, cold storage and meat van
12. Complete upgraded facilities/medical laboratory, dental equipment and instruments – all medical facilities not found in the city
13. Wellness Center facilities for the promotion of healthy lifestyle
14. Modern hospital building to house all medical upgrading facilities for all types of patients including PWDs
15. Establishment of renewable energy facilities such as solar power plants, etc.
16. Establishment of forest/tree park/flower park
17. Upgrading of the category of the Tuguegarao City Peoples General Hospital (TCPGH) or a hospital to be built, not only primary or secondary but tertiary






