CITY RESOLUTION NO. 100-08-2020

RESOLUTION GRANTING ONE-MONTH RENTAL CONDONATION OF STALLS AT THE TUGUEGARAO CITY COMMERCIAL CENTER (TCCC) AND PEOPLE'S GYMNASIUM FROM MARCH 20, 2020 TO APRIL 20, 2020

WHEREAS, the World Health Organization (WHO) declared on March 12, 2020 that COVID-19 has become a "pandemic";

WHEREAS, President Rodrigo Roa Duterte has issued Executive Order No. 922 declaring a State of Public Health Emergency due to novel corona virus disease (COVID19) and subsequently ordered for the Enhanced Community Quarantine (ECQ) of the entire Luzon;

WHEREAS, on the basis of the above orders, the Eighth City Council passed and approved City Resolution No. 097-08-2020 "Resolution Adopting and Approving City Disaster Risk Reduction and Management Council Resolution No. 02-2020 titled "Resolution Recommending the Declaration of Tuguegarao City under a state of Public Health Emergency due to the Threat of Corona Virus Disease (COVID) 2019";

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has issued Executive Order No. 28, series of 2020 "An Order Implementing the Strict Home Quarantine in All Households Beginning March 17, 2020 to April 14, 2020 in Tuguegarao City";

WHEREAS, on March 16, 2020, President Rodrigo Duterte declared a state of calamity in the Philippines for six months through Proclamation No. 929 as cases of the novel coronavirus in the country continue to rise;

WHEREAS, relative to the above premises, work-from-home arrangements have been made while most establishments were directed to close;

WHEREAS, in order to ease the burden of the affected stall owners, the City Mayor, Hon. Atty. Jefferson, has requested the Eighth City Council for the passage of a resolution condoning one-month rental of stalls at the Tuguegarao City Commercial Center (TCCC) and People's Gymnasium;

WHEREAS, the Eighth City Council during their Special Session held on March 20, 2020 deemed it proper, necessary and urgent to approve the herein request being beneficial to the concerned constituents of the City.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to grant one-month rental condonation of stalls at the Tuguegarao City Commercial Center (TCCC) and People's Gymnasium from March 20, 2020 to April 20, 2020.

RESOLVED FURTHER, that the rental payment from February 20, 2020 to March 20, 2020 shall be made upon resumption of working days/office hours of the City Government of Tuguegarao, without interests and surcharges.

On joint motion, CITY RESOLUTION NO. 100-08-2020 was APPROVED under suspended rules.
