# CITY RESOLUTION NO. 102-08-2020

### RESOLUTION GRANTING A 45-DAY PERIOD EXTENSION FROM THE DUE DATE/DEADLINE OF SUBMISSION TO SUBMIT THE REQUIRED ADDITIONAL DOCUMENTS OF BUSINESSES ISSUED WITH TEMPORARY BUSINESS PERMITS

WHEREAS, the World Health Organization (WHO) declared on March 12, 2020 that COVID-19 has become a "pandemic";

WHEREAS, President Rodrigo Roa Duterte has issued Executive Order No. 922 declaring a State of Public Health Emergency due to novel corona virus disease (COVID19) and subsequently ordered for the Enhanced Community Quarantine (ECQ) of the entire Luzon;

WHEREAS, on the basis of the above orders, the Eighth City Council passed and approved City Resolution No. 097-08-2020 "Resolution Adopting and Approving City Disaster Risk Reduction and Management Council Resolution No. 02-2020 titled "Resolution Recommending the Declaration of Tuguegarao City under a state of Public Health Emergency due to the Threat of Corona Virus Disease (COVID) 2019";

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has issued Executive Order No. 28, series of 2020 "An Order Implementing the Strict Home Quarantine in All Households Beginning March 17, 2020 to April 14, 2020 in Tuguegarao City";

WHEREAS, on March 16, 2020, President Rodrigo Duterte declared a state of calamity in the Philippines for six months through Proclamation No. 929 as cases of the novel coronavirus in the country continue to rise;

WHEREAS, the City Mayor, Hon. Atty. Jefferson, has requested the Eighth City Council for the passage of a resolution granting 45-day period extension to submit the required documents of businesses issued with temporary business permits;

WHEREAS, the Eighth City Council during their Special Session held on March 20, 2020 deemed it proper, necessary and urgent to approve the herein request being beneficial to the concerned constituents of the City.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to grant a 45-day period extension from the due date/deadline of submission to submit the required additional documents of businesses issued with temporary business permits.

On joint motion, CITY RESOLUTION NO. 102-08-2020 was APPROVED under suspended rules.
