WHEREAS, the World Health Organization (WHO) declared on March 12, 2020 that COVID-19 has become a “pandemic”;

WHEREAS, President Rodrigo Duterte through an Executive Order has declared a State of Public Health Emergency due to the Novel Corona Virus Disease (COVID-19) and has recently ordered an enhanced community quarantine of the entire Luzon;

WHEREAS, the Cagayan Valley Regional Inter-Agency Task Force for COVID-19 confirmed the first case of coronavirus disease 2019 (COVID-19) in Region 2 on March 21, 2020 after a patient who arrived from Manila tested positive for the viral disease;

WHEREAS, there is a need to prevent the continued and accelerated spread of COVID-19 in Tuguegarao City;

WHEREAS, two measures that can effectively contain the spread of the virus are to strictly implement home quarantine and to close non-food establishments;

WHEREAS, all banks in the City operate from 9:00AM to 1:00PM during weekdays, from Monday to Friday;


WHEREAS, it has been observed that there are banks operating during Saturdays despite the implementation of enhanced community quarantine.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to urge all banks in the city to stop from operating on Saturdays due to COVID-19.
