**A RESOLUTION TEMPORARILY IMPOSING LIQUOR/ALCOHOL BAN IN TUGUEGARAO CITY AS A PRECAUTIONARY MEASURE TO BOOST THE IMPLEMENTATION OF COMMUNITY QUARANTINE**

**WHEREAS**, Presidential Proclamation No. 922 declared the entire Philippines under Public Health Emergency to COVID-19;

**WHEREAS**, to immediately manage and control the spread of COVID-19, the country is placed under enhanced community quarantine and social distancing is being strictly implemented from March 17, 2020 to April 14, 2020;

**WHEREAS**, due to the sudden increase of the infected persons of the deadly corona virus, the President issued Proclamation No. 929 declaring the Philippines under the State of Calamity;



**WHEREAS**, to safeguard further the health and safety of all residents and to maintain peace and order in Tuguegarao City, there is a need to control the sale and consumption of liquor/alcohol in Tuguegarao City as a precautionary measure to boost the implementation of community quarantine;

**WHEREAS**, this resolution is for the entire duration of the enhanced community quarantine and shall be subjected to the penalties provided under national laws.


**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to temporarily impose liquor/alcohol ban in Tuguegarao City as a precautionary measure to boost the implementation of community quarantine.

**RESOLVED FURTHER**, copies of this resolution shall be furnished to all business establishments selling alcohol/liquors in the city.
