RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO NEGOTIATE AND ENTER INTO A SHORT TERM LEASE AGREEMENT WITH ESTABLISHMENTS TO BE USED AS QUARANTINE AREAS FOR RESIDENTS OF TUGUEGARAO CITY FROM AREAS WHICH HAVE LOCAL COVID-19 CONTAMINATION

WHEREAS, His Excellency President Rodrigo Roa Duterte issued Proclamation No. 929 on March 16, 2020 declaring a State of Calamity throughout the Philippines in view of the escalating and continuous rise of confirmed COVID-19 cases despite government interventions;

WHEREAS, on March 16, 2020, the entire Luzon area was placed under enhanced community quarantine in response to the growing pandemic of COVID-19;

WHEREAS, the Cagayan Valley Regional Inter-Agency Task Force for COVID-19 confirmed the first case of coronavirus disease 2019 (COVID-19) in Region 2 on March 21, after a patient who arrived from Manila tested positive for the viral disease;

WHEREAS, contact tracing of the confirmed case is now currently being undertaken by the Regional Epidemiology and Surveillance Unit and personnel from the City Health Office of Tuguegarao, where close contacts have been identified and are now being closely monitored;

WHEREAS, there is a need for these close contacts and other persons under investigation and monitoring from areas which has local COVID-19 contamination to be placed in a quarantine area;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has requested the Eighth City Council to authorize him to negotiate and enter into a short term lease agreement with establishments to be used as quarantine areas for residents of Tuguegarao City from areas which has local COVID-19;


WHEREAS, the Eighth City Council in its Special Session held on March 26, 2020 found the request for authority to be in order, with merit and beneficial to the constituents of Tuguegarao City.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to authorize the City Mayor, Hon. Atty. Jefferson P. Soriano, to negotiate and enter into short term lease agreement with establishments to be used as quarantine areas for residents of Tuguegarao City from areas which has local COVID-19 contamination.


On joint motion, **CITY RESOLUTION NO. 123-08-2020** was **APPROVED** under suspended rules.
