WHEREAS, the World Health Organization (WHO) declared on March 12, 2020 that COVID-19 has become a “pandemic”;

WHEREAS, His Excellency President Rodrigo Roa Duterte has issued Executive Order No. 922 declaring a State of Public Health Emergency due to novel corona virus disease (COVID19) and subsequently ordered for the Enhanced Community Quarantine (ECQ) of the entire Luzon;

WHEREAS, on March 16, 2020, the country was placed under a state of calamity for six months as declared by President Duterte through Proclamation No. 929 in view of the escalating rise of COVID-19 cases;

WHEREAS, on the basis of the above orders, the Eighth City Council passed and approved City Resolution No. 097-08-2020 “Resolution Adopting and Approving City Disaster Risk Reduction and Management Council Resolution No. 02-2020 titled “Resolution Recommending the Declaration of



Tuguegarao City under a state of Public Health Emergency due to the Threat of Corona Virus Disease (COVID) 2019”;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has issued Executive Order No. 28, series of 2020 “*An Order Implementing the Strict Home Quarantine in All Households Beginning March 17, 2020 to April 14, 2020 in Tuguegarao City*”;

WHEREAS, relative to the above premises, strict home quarantine is being implemented and only one household member with a Pass is allowed to go out and buy the basic needs of the family;

WHEREAS, considering that the city is undergoing unusual and uncertain circumstances due to COVID-19 and in order to ease the burden of the public who buy their basic commodities at the Tuguegarao City Commercial Center, the lessor of the basement parking area has made the parking free for the public.

WHEREAS, the City Mayor, Hon. Atty. Jefferson, has requested the Eighth City Council to condone the rentals of the basement parking area of the Tuguegarao City Commercial Center;


WHEREAS, the Eighth City Council during their Special Session held on March 26, 2020 deemed it proper, necessary and urgent to approve the herein request being beneficial to the concerned constituents of the City.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to condone the rentals of the basement parking area of the Tuguegarao City Commercial Center during the Enhanced Community Quarantine period.
