CITY RESOLUTION NO. 126-08-2020

RESOLUTION AUTHORIZING THE TEMPORARY ESTABLISHMENT OF FIVE SATELLITE PUBLIC MARKETS IN TUGUEGARAO CITY TO PREVENT THE CONTINUED SPREAD OF COVID-19

WHEREAS, His Excellency President Rodrigo Roa Duterte issued Proclamation No. 922 on March 8, 2020 declaring a State of Public Health Emergency due to Novel Corona Virus Disease (COVID-19);

WHEREAS, the World Health Organization (WHO) declared on March 12, 2020 that COVID-19 has become a “pandemic”;

WHEREAS, the country was placed under a state of calamity for six months on March 16, 2020 by President Duterte through Proclamation No. 929;

WHEREAS, on the same date, the entire Luzon area was placed under enhanced community quarantine enforcing a total lockdown which restricts the movement of the population;

WHEREAS, Proclamation No. 929 was also issued by President Duterte on March 16, 2020 declaring a State of Calamity throughout the Philippines in view of the continuous rise of COVID-19 cases;

WHEREAS, the City Government of Tuguegarao has implemented and enforced several executive orders from the City Mayor, Hon. Atty. Jefferson P. Soriano, to prevent the continued spread of COVID-19 in the city;

WHEREAS, the Eighth City Council has likewise adopted and passed a number of resolutions and ordinances relative to COVID-19;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested the Eighth City Council for the establishment of five satellite markets in the following strategic places in Tuguegarao City to decongest the number of people going to Tuguegarao City Central Market (Don Domingo) and regulate the movement of residents:

1. Libag Norte Gymnasium
2. Cataggaman Nuevo Gymnasium
3. Pallua Sur Gymnasium
4. De Guzman Bodega beside Victory Bus Liner in front of Petron Gasoline Station
5. Gymnasium beside Atulayan Elementary School along Provincial Road, Atulayan Sur

WHEREAS, the suggested retail prices of the goods and commodities shall be conspicuously displayed in tarpaulins and the like in the satellite markets;

WHEREAS, the assistance of accredited Civil Society Organizations (CSOs) shall be sought in the implementation of this resolution.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to authorize the temporary establishment of five satellite public markets Tuguegarao City to prevent the continued spread of COVID-19:

1. Libag Norte Gymnasium
2. Cataggaman Nuevo Gymnasium
3. Pallua Sur Gymnasium
4. De Guzman Bodega beside Victory Bus Liner in front of Petron Gasoline Station
5. Gymnasium beside Atulayan Elementary School along Provincial Road, Atulayan Sur


RESOLVED FURTHER, that in order to safeguard the consumers, the Department of Trade and Industry (DTI) and the Local Government Unit of Tuguegarao through its Price Monitoring Council shall regulate and monitor the prices of goods/commodities being sold.

RESOLVED FINALLY, that the operation of the satellite markets shall be from 5:00AM to 12:00NN.


On motion, **CITY RESOLUTION NO. 126-08-2020** was **APPROVED**.
