 “A RESOLUTION ENDORSING TO THE 8TH TUGUEGARAO CITY COUNCIL THE APPROVAL
 OF THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM CY 2020 FOR
 SUPPLEMENTAL BUDGET NO. 02 CY 2020”**

WHEREAS, His Excellency President Rodrigo Roa Duterte issued Proclamation No. 929 on March 16, 2020 declaring a State of Calamity throughout the Philippines in view of the escalating and continuous rise of confirmed COVID-19 cases despite government interventions;

WHEREAS, on March 16, 2020, the entire Luzon area was placed under enhanced community quarantine in response to the growing pandemic of COVID-19;

WHEREAS, DBM Budget Circular No. 2020-1 provides the guidelines on the grant of COVID-19 Hazard Pay while DBM-DILG JMC No. 01 dated March 27, 2020 provides the guidelines on the utilization of the 20% Annual Internal Revenue Allotment for development projects in view of the Corona Virus Disease 2019 Situation;

WHEREAS, the Local Finance Committee certified that the amount of **THIRTY-SEVEN MILLION SIX HUNDRED FIFTY-SIX THOUSAND PESOS (P37,656,000.00)** is free from any obligation and is available for appropriation;

WHEREAS, City Development Council (CDC) Resolution No. 02-2020 is in accordance with the prescribed guidelines, rules and regulations;

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to adopt and approve City Development Council (CDC) Resolution No. 02-2020 titled “*Resolution Endorsing to the 8th Tuguegarao City Council the Approval of the Supplemental Annual Investment Program CY 2020 for Supplemental Budget No. 02 CY 2020.*”


