**RESOLUTION URGING BUSINESS OPERATORS OF DRUGSTORES, GASOLINE STATIONS, GROCERIES, FOOD AND CONVENIENT STORES OR SIMILAR ESTABLISHMENTS TO PROVIDE A SPECIAL LANE FOR FRONTLINE HEALTH WORKERS IN TUGUEGARAO CITY**

**WHEREAS**, on March 17, 2020, President Rodrigo R. Duterte issued Proclamation No. 929 placing the entire Luzon under Enhanced Community Quarantine (ECQ) to contain the spread of COVID-19;

**WHEREAS**, COVID-19 had accelerated and claimed the lives of our fellow countrymen including the loss of our brave Filipino health workers;

**WHEREAS**, some of the health workers who were afflicted by COVID-19 came from Tuguegarao City and most of the health workers are still working very hard just to provide medical attention to needy patients in the hospital;

**WHEREAS**, Section 4 of Bayanihan Heal as One Act gives special risk attention for frontline health workers;

**WHEREAS**, majority of our health workers have minimal time in buying their basic needs due to their hectic hospital duties;

**WHEREAS**, there is a need for business operators abovementioned to extend support and give attention and special lane to our frontline health workers as a gesture for our gratitude for their tireless efforts in providing us medical services in the midst of this dreadful corona virus disease.


**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to urge business operators of drugstores, gasoline stations, groceries, food and convenient stores or similar establishments to provide a special lane for frontline health workers in Tuguegarao City.

**RESOLVED FURTHER**, that this Resolution shall take effect immediately upon its approval until April 14, 2020 unless the emergency situation is extended or withdrawn by the National Government.


On joint motion, **CITY RESOLUTION NO. 130-08-2020** was **APPROVED** under suspended rules.
