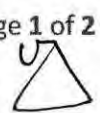
**A RESOLUTION STRONGLY URGING ALL BUSINESS OWNERS TO DISINFECT

WHEREAS, the number of total COVID-19 confirmed cases in the whole world as of April 29, 2020 has exceeded 3 million according to the World Health Organization;

WHEREAS, in the Philippines, there have been 8,212 confirmed cases of the disease as of April 29, 2020 and of these cases, there have been 1,023 recoveries and 558 deaths recorded.

WHEREAS, the Philippines has the third most number of cases in Southeast Asia, after Singapore and Indonesia.



WHEREAS, in Cagayan Valley, there have been 31 cases recorded and of these cases, there have been one death, 8 active cases and 22 recoveries as of April 29, 2020:

WHEREAS, the Province of Cagayan has been placed under General Community Quarantine starting May 1, 2020 by the Inter-Agency Task Force on Emerging Diseases (IATF-EID);

WHEREAS, there is a need to adopt stringent measures to avoid the spread and transmission of the deadly CORONA VIRUS-19;


WHEREAS, one of these measures is for business owners to disinfect their establishments after closing time ready for the next day operation.


On joint motion, **CITY RESOLUTION NO. 138-08-2020** was **APPROVED** under suspended rules.
