**A RESOLUTION REQUESTING FOR THE DEPLOYMENT OF SOME CITY GOVERNMENT EMPLOYEES TO THE DIFFERENT BARANGAYS FOR REINFORCEMENT PURPOSES**

**WHEREAS**, the Province of Cagayan has been placed under General Community Quarantine starting May 1, 2020 by the Inter Agency Task Force on Emerging Diseases (IATF-EID);

**WHEREAS**, there is still a pressing need to implement stringent measures to prevent the spread and transmission of COVID-19, two of which are home quarantine and physical distancing;

**WHEREAS**, Work from home arrangement and other similar alternatives have been considered and implemented by the City Government of Tuguegarao;

**WHEREAS**, during the 38<sup>th</sup> Regular Session of the 8<sup>th</sup> City Council held on April 30, 2020, it was manifested by the President of the Liga ng mga Barangay that the barangays need manpower reinforcement especially Information Technology employees who could help them in their documents.



On joint motion, **CITY RESOLUTION NO. 140-08-2020** was **APPROVED** under suspended rules.


