**CITY RESOLUTION NO. 141-08-2020**

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE PUBLIC PRIVATE PARTNERSHIP (PPP) CENTER AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA**

**WHEREAS**, Section 20, Article II of the 1987 Philippine Constitution provides that the State recognizes the indispensable role of the private sector, encourages private enterprise and provides incentive to needed investments;

**WHEREAS**, the Tuguegarao City Government continuously enters into various agreements with the private sector in the realization of its programs, projects and activities for the general welfare of its constituents;

**WHEREAS**, the Tuguegarao City Government sought technical assistance from the Public-Private Partnership (PPP) Center in its several development projects for which PPP Center signified its willingness to provide such assistance and to collaborate with its projects;

**WHEREAS**, in order to make the partnership between the PPP Center and the Tuguegarao City Government legally binding, there is a need to approve the Memorandum of Agreement to be entered into by both parties;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, endorsed to the Eight City Council the said Memorandum of Agreement (MOA) with Public-Private Partnership (PPP) Center and requested to grant him an authority to sign for and on behalf of the Tuguegarao City Government the said MOA.

**WHEREAS**, the Eight City Council during their 39<sup>th</sup> Regular Session deemed it proper, necessary and beneficial to grant the herein request;


