RESOLUTION EXTENDING WARM AND SINCEREST GRATITUDE TO JUBILEE CHRISTIAN ACADEMY BATCH 2002 FOR FACILITATING THE DONATIONS OF ROTARY CLUB METRO MANILA PUGAD LAWIN AND UAP METRO MANILA OF THREE COVID-19 TESTING BOOTHS TO TUGUEGARAO CITY

WHEREAS, His Excellency President Rodrigo Duterte issued Proclamation No. 922 on March 8, 2020 declaring a State of Public Health Emergency due to Novel Corona Virus Disease (COVID-19);

WHEREAS, the World Health Organization (WHO) declared on March 12, 2020 that COVID-19 has become a “pandemic”;

WHEREAS, the country was placed under a state of calamity for six months on March 16, 2020 by President Duterte through Proclamation No. 929 and on the same date, the entire Luzon area was placed under Enhanced Community Quarantine;

WHEREAS, the Enhanced Community Quarantine was extended up to April 30, 2020;

WHEREAS, the Province of Cagayan was categorized on May 1, 2020 as a General Community Quarantine (GCQ) Area;

WHEREAS, in the Philippines, there have been 10,794 confirmed cases of the disease as of May 11, 2020 and of these cases, there have been 1,924 recoveries and 719 deaths recorded;

WHEREAS, in Cagayan Valley, there have been 31 cases recorded and of these cases, there have been one death, 8 active cases and 22 recoveries as of April 29, 2020;



WHEREAS, it is imperative to safeguard the general public and frontliners especially the health workers who facilitate the testing from CORONA VIRUS 2019 (COVID-19), hence, there is a need for COVID-19 Testing Booths which shall perform quick and efficient COVID-19 tests;

WHEREAS, the Jubilee Christian Academy Batch 2002 facilitated the donations of Rotary Club Metro Manila Pugad Lawin and UAP Metro Manila of Three COVID-19 Testing Booths to Tuguegarao City;


WHEREAS, the said testing booths were turned-over to the Tuguegarao City Health Office before the declaration of Enhanced Community Quarantine.
