WHEREAS, Tuguegarao City is the Regional Center of Region 02 and is the center of education, commerce and governance;

WHEREAS, as the regional center, the population of the city increases three folds especially during day time;

WHEREAS, due to the increase in population, there is a need for additional police force to maintain peace and order;

WHEREAS, the Local Government of Tuguegarao City and the Philippine National Police share the same goal which is to eliminate all forms of criminality and breach of the peace to ensure safety of lives and property;

WHEREAS, as per record of the Tuguegarao City Police Station, the ratio of police to the population is 1:773 which is one police officer to seven hundred seventy-three persons in the city;

WHEREAS, the growing populations of Tuguegarao City makes it difficult for the police force to secure the whole of Tuguegarao City in times of calamity and unprecedented situations;

WHEREAS, it has been recognized and proven that police presence and visibility is still the most effective deterrent to curb criminal elements and activities.




