CITY RESOLUTION NO. 159-08-2020

A RESOLUTION DESIGNATING THREE (3) TRANSPORT TERMINALS/STOPS FOR THE DURATION OF THE NATIONAL EMERGENCY (GENERAL COMMUNITY QUARANTINE)

WHEREAS, the entire Province of Cagayan is now categorized as a GENERAL COMMUNITY QUARANTINE (GCQ) area, a shift from the ENHANCED COMMUNITY QUARANTINE (ECQ) category wherein most if not the entire population was confined to residence;

WHEREAS, under GCQ, a limited number of local public transport may now operate under certain terms and conditions to be specified in a Special Permit to be issued by the Land Transportation Franchising Board (LTFRB), Regional Office No. 02;

WHEREAS, under this present emergency situation, the city government designated only three (3) transport terminals/stops to accommodate those transport utility vehicles to be allowed by the LTFRB so that there will be an efficient management of passengers and visitors to the city particularly for “contact tracing”;

WHEREAS, the operation of vans and buses shall be subject to the provisions of Memorandum Circular 2020-017 titled *Guidelines for Public Transportation for Areas under General Community Quarantine* issued by the Department of Transportation (DOTr);

WHEREAS, terminals/stops shall first comply with sanitary requirements before operation;

WHEREAS, following the structure laid out in the Comprehensive Land Use Plan for the city, one (1) transport terminal shall be designated for those coming from the North; another for those coming from the East; and, another for those coming from the West;

NOW, THEREFORE, RESOLVE as it is hereby **RESOLVED**, to designate the following transport terminals/stops as temporary terminals/stops during this emergency period, viz:

- a. Those coming from the North, the Tuguegarao City Central Terminal located along the Maharlika Highway at Barangay Leonarda;
- b. Those coming from the West, the Magno Lim terminal along Diversion Road at Barangay Ugac Norte;
- c. Those coming from the East, the terminal located along Macapagal Avenue at Barangay Tanza.


RESOLVED FURTHER, to require these designated transport terminals/stops to install Closed Circuit Television (CCTV) cameras for monitoring of passengers for "contact tracing" purposes; foot baths, hand-washing areas, conduct of thermal scanning of all passengers going in and out of the terminal, and, disinfecting the terminal regularly.

RESOLVED, FINALLY, that this temporary designation of terminals/stops shall be valid only during the duration of the COVID-19 emergency period (General Community Quarantine).


On joint motion, **CITY RESOLUTION NO. 159-08-2020** was **APPROVED** under suspended rules.
