WHEREAS, the Civil Service Commission, Regional Office No. 02, Tuguegarao City is now accepting nominations for 2020 Honor Awards both in the individual and group categories who shall qualify in the national search for the three awards classifications, namely, the Presidential Lingkod Bayan, Civil Service Commission Pagasa, and Dangal ng Bayan Awards;

WHEREAS, the Program on Awards and Incentives for Service Excellence (PRAISE) Committee of Tuguegarao City has unanimously approved Resolution No. 03, series of 2020 recommending the nomination of Hon. Atty. Jefferson P. Soriano, City Mayor, for the “Presidential Lingkod Bayan Award”

pursuant to the provisions of Memorandum Circular No. 01, series of 2001 of the Civil Service Commission (CSC);

WHEREAS, Hon. Atty. Jefferson P. Soriano was elected City Mayor of Tuguegarao City in 2013, 2016 and 2019 enjoying the trust and confidence of Tuguegaraoños by reason of his exemplary leadership, tangible accomplishments and endearing concerns for the general welfare of his constituents;

WHEREAS, through effective and efficient governance, Mayor Jefferson P. Soriano is acknowledged to have initiated among others the following projects, programs and services, as follows:

1. The institutionalization of Barangay People's Day every Friday bringing basic services to the people;


