WHEREAS, the current Administration has directed all Cabinet Members to immediately implement poverty reduction projects in all regions;

WHEREAS, the Department of Labor and Employment (DOLE) is mandated to promote gainful employment opportunities, develop human resources, protect workers and promote their welfare, and maintain industrial peace;

WHEREAS, the DOLE endeavors to contribute to reducing poverty and vulnerability to risks of the poor, vulnerable and marginalized workers by providing them access to livelihood undertakings;

WHEREAS, the DOLE will provide a capacity building facility on livelihood and entrepreneurial ventures for the workers in the informal economy and the vulnerable groups of workers such as parents of child laborers, women, youth, persons with disabilities, indigenous peoples, among others, under the DOLE Livelihood (Kabuhayan) Program, pursuant to the provisions of DO No. 137, series of 2014;

WHEREAS, DOLE-RO2 has been given the responsibility to implement the DOLE Livelihood (Kabuhayan) Program to enable the employed poor, seasonal and low-wage workers to start individual livelihood or collective enterprise undertaking with the goal of moving them out of poverty and making them productive;

WHEREAS, DOLE-RO2 shall implement the foregoing livelihood intervention in the City of Tuguegarao, Province of Cagayan, in partnership with the LGU-Tuguegarao City as accredited co-partner;

WHEREAS, this partnership is vital to ensure the successful implementation of the said projects and achieve their desired social outcomes;


WHEREAS, the Proponent has been accredited by DOLE to be capable and experienced in implementing the proposed projects of the 45 beneficiaries, particularly the Starter Kit Project (Rice Retailing, Product Retailing, Street Food Vending, Carinderia, Frozen Food, Kakanin Processing and Ice Processing) located at the various barangays of Tuguegarao City, Cagayan.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to concur/ratify the Memorandum of Agreement with the Department of Labor and Employment-Regional Office No. 02 (DOLE-RO2) for the implementation of the DOLE Kabuhayan Program to be entered into by and between the Tuguegarao City Government and DOLE-RO2.
