**CITY RESOLUTION NO. 165-08-2020**

**RESOLUTION URGING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO ISSUE CEASE AND DESIST ORDER TO THE ONGOING CELL SITE/TOWER CONSTRUCTION AT AQUINO AND ALAN STREETS, ANNAFUNAN WEST AND ALL OTHER ONGOING CELL SITE CONSTRUCTIONS PENDING THE APPROVAL OF “DRAFT ORDINANCE REGULATING THE CONSTRUCTION, INSTALLATION, OPERATION AND UPGRADING OF CELLULAR SITES/TOWERS FOR MOBILE PHONE SERVICES IN TUGUEGARAO CITY”**

**WHEREAS**, during the 45<sup>th</sup> Regular Session of the 8<sup>th</sup> City Council held on June 16, 2020, Hon. Atty. Raymund P. Guzman, Chair of the Committee on Rules, Laws and Ethics, informed the Body of a letter of complaint against the ongoing construction of a cell site/tower at Aquino and Alan Streets, Annafunan West;

**WHEREAS**, the latter complaint alleged that there was no public hearing held for the said purpose and that the construction poses health dangers to the community specially the children, hence, their appeal for the stoppage of the construction;

**WHEREAS**, “Draft Ordinance Regulating the Construction, Installation, Operation and Upgrading of Cellular Sites/Towers for Mobile Phone Services in Tuguegarao City” is scheduled for a Public Hearing on June 16, 2020 at 1:00 P.M.;

**WHEREAS**, in view of the foregoing premises, the 8<sup>th</sup> City Council deems it necessary to urge the City Mayor, Hon. Atty. Jefferson P. Soriano, to Issue Cease and Desist Order to the Ongoing Cell Site Construction at Aquino and Alan Streets, Annafunan West meantime that it has not filed yet for RONO application as alleged;

**WHEREAS**, it was also decided that all other Ongoing Cell Site/Tower Constructions be stopped pending the approval of the ordinance.




On joint motion, **CITY RESOLUTION NO. 165-08-2020** was **APPROVED** under suspended rules.
