# CITY RESOLUTION NO. 166-08-2020

# RESOLUTION DISMISSING THE LETTER-COMPLAINT AGAINST BARANGAY KAGAWAD REMALYN M. ADDUN FILED BY MRS. MYRNA G. TE DUE TO NON-CONFORMITY TO FORM

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, endorsed to the Eighth City Council the letter-complaint against Barangay Kagawad Remalyn M. Addun filed by Mrs. Myrna G. Te;

WHEREAS, the said indorsement was included in the agenda of the 45<sup>th</sup> Regular Session of the Sangguniang Panlungsod held on June 16, 2020;

WHEREAS, it was decided by the Body to defer the consideration of the matter since it is not verified and notarized, and write a letter to Mrs. Myrna G. Te to comply within ten (10) days upon receipt;

WHEREAS, Mrs. Te was not able to submit a verified/notarized complaint within ten (10) days upon her receipt of the letter and neither an Affidavit of Ms. Analyn Maura and Mrs. Karen Paragas;

WHEREAS, Section 61 of the Local Government Code – Form and filing of Administrative Complaints (c) A verified complaint against any elective barangay official shall be filed before the Sangguniang Panlungsod or Sanggunian concerned whose decision shall be final and executory";

WHEREAS, Section 2 of City Ordinance No. 19-2000 titled "An Ordinance Providing for the Rules and Regulations in the Investigation, Hearing and Disposition of Administrative Cases against Elective Barangay Officials" which provides that "Administrative complaint against any elective barangay official of Tuguegarao City shall be filed before the city council, through the Office of the City Council Secretary. The complaint must be verified in accordance with law. Otherwise, the complaint shall be immediately returned to the last known address of the complainant for verification".
