CITY RESOLUTION NO. 167-08-2020

RESOLUTION REQUESTING ALL NATIONAL GOVERNMENT OFFICES INCLUDING GOVERNMENT-OWNED AND CONTROLLED CORPORATIONS IN TUGUEGARAO CITY TO DISINFECT THEIR OFFICES AT LEAST ONCE A WEEK TO PREVENT AND AVOID THE TRANSMISSION OF COVID-19 VIRUS

WHEREAS, Tuguegarao City is at present under General Community Quarantine (GCQ) as per the recommendation of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases;

WHEREAS, with Tuguegarao City under GCQ, quarantine protocols have become less stringent as evidenced by the opening of several establishments, reduction in the number of curfew hours and permits to some individuals to go out and buy basic necessities;

WHEREAS, although there are still practices not allowed under GCQ guidelines including backriding for single motorcycles, having more than one passenger in tricycles and mass gatherings, the risk to be infected by the deadly virus should not be set aside;

WHEREAS, the Balik-Probinsya Program of the National Government should also be put into consideration since a number of Locally Stranded Individuals (LSIs) from other places are coming back to Tuguegarao City and although following health protocols on quarantine, these LSIs have different travel histories;

WHEREAS, the strict implementation of the correct wearing of face mask and temperature checks as well as physical and social distancing is still in effect and very effective in combatting the transmission of the virus;

WHEREAS, despite of the strict implementation of a number of measures, other necessary precautionary actions must also be put in effect because the threat of COVID-19 is still very much evident and could even be considered “the Sword of Damocles” because of the sense of foreboding it brings; and

WHEREAS, it is for these imperative reasons that there is a need for national government offices including government-owned and controlled corporations in Tuguegarao City to disinfect their offices at least once a week to curb or prevent the spread of the deadly virus considering the fact that there are a number of clients from different places who transact business with them.


