CITY RESOLUTION NO. 173-08-2020

RESOLUTION CONCURRING/RATIFYING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE), REGIONAL OFFICE NO. 2 ON THE IMPLEMENTATION OF THE TUPAD PROGRAM

WHEREAS, Section 9 of the Philippine Constitution on state policies provides that the State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all.

WHEREAS, pursuant to the above mandate, the current administration gave a directive to all concerned national and local agencies to implement poverty reduction projects most specially in this time when most Filipinos are suffering because of the effects of COVID-19 pandemic;

WHEREAS, the Tuguegarao City Government always gives priority to programs and projects that would ease or elevate the lives of every family in the City, more so, of those who became unemployed because of the said pandemic;

WHEREAS, the Department of Labor and Employment (DOLE) is specifically mandated to promote gainful employment opportunities, develop human resources, protect workers and promote their welfare and maintain industrial peace;

WHEREAS, with the said mandate, the Department of Labor and Employment (DOLE) provides assistance to under employment, self-employed workers and displaced marginalized workers who have lost their livelihood or whose earnings were affected during or after the implementation of the community quarantine to assist their recovery from income losses and to augment their meager income under the TULONG PANGHANAPBUHAY SA ATING DISPLACED/DISADVANTAGED (TUPAD)

WORKERS PROGRAM, pursuant to the provisions of DO No. 173, series of 2017 and AO 114, series of 2020;

WHEREAS, DOLE-RO 02 has been given the responsibility to implement the TUPAD Program particularly the "Planting of Bamboo Trees Along Cagayan and Pinacanauan Rivers, Urban Gardening, Disinfection/Sanitation of Houses/Dwellings; Delivery of Essential Goods and Services, Packing of Relief Goods; Transport Services for Frontliners or in Setting Up Mobile Markets and other Related Tasks Assigned by LGUs"

WHEREAS, the partnership of DOLE-RO 2 and the Tuguegarao City Government for the herein project is imperative to guarantee its successful implementation in order to achieve its desired social outcomes

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has indorsed to the Eighth City Council the MOA for ratification and concurrence.

WHEREAS, the Eighth City Council during their 47th Regular Session held on June 30, 2020 deemed it proper, necessary and beneficial to approve the herein indorsement.

NOW, **THEREFORE**, **RESOLVE**, as it is hereby **RESOLVED**, to concur/ratify the Memorandum of Agreement (MOA) between the Tuguegarao City Government and the Department of Labor and Employment (DOLE), Regional Office No. 02 on the Implementation of the TUPAD Program.

RESOLVED FURTHER, to furnish a copy of this resolution to Department of Labor and Employment (DOLE), Regional Office No. 02, for information and proper action.
