CITY RESOLUTION NO. 175-08-2020

RESOLUTION STRONGLY RECOMMENDING AND SUPPORTING THE CONVERSION OF ANNAFUNAN ELEMENTARY SCHOOL INTO ANNAFUNAN INTEGRATED SCHOOL

WHEREAS, Sections 1 and 2 (1) of Article XIV of the Philippine Constitution provide that the State shall protect and promote the right of all citizens to quality education at all levels, shall take appropriate steps to make such education accessible to all and shall establish, maintain and support a complete, adequate and integrated system of education relevant to the needs of the people and society;

WHEREAS, the Department of Education (DepEd) and the Tuguegarao City Government work hand in hand with their best efforts to realize their goals on education as articulated in herein constitutional provisions;

WHEREAS, DepEd Order No. 40, series of 2014, otherwise known as the Establishment, Merging, Conversion and Naming/Renaming of Public Schools and Separation of Public School Annexes in Basic Education, enumerates the guidelines in the conversion of a school into an integrated school either through the expansion of an elementary or secondary school, or the combination of existing elementary and secondary schools adjacent to each other into one, provided there is a duly approved sanggunian resolution for such purpose;

WHEREAS, pursuant to the above constitutional provision and order, the Local School Board has approved Resolution No. 11-2020 titled "*A Resolution Supporting and Strongly Recommending to the 8th City Council the approval of the Conversion of Annafunan Elementary School into Annafunan Integrated School*";

WHEREAS, a resolution was jointly passed by the Parents and Teachers Association (PTA) of Annafunan Elementary School, Annafunan East Barangay Council and Annafunan West Barangay Council



requesting for the Conversion of Annafunan Elementary School into an Integrated School that offers Kindergarten, Elementary, Junior High School and Senior High School;

WHEREAS, the conversion of Annafunan Elementary School into an Integrated School will enable the same to offer basic education program including high school grades to students around the locality thereby benefitting students of the said area and its neighboring barangays thereby cutting, too, their transportation expenses;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, indorsed to the Eighth City Council the herein-stated resolution of the Local School Board, for approval;

WHEREAS, after a deliberation in a committee meeting held for the said purpose, the Joint Committee on Education and Committee on Rules, Laws and Ethics found the request to be in order and beneficial to the constituents of Tuguegarao City particularly the students and their parents who would be benefitted hereof;

WHEREAS, after the presentation and adoption of Committee Report No. 049-2020, the Eighth City Council during their 47th Regular Session held on June 30, 2020 deemed it proper and necessary to approve the herein indorsement.


