A RESOLUTION EARNESTLY APPEALING TO ALL PRIVATE SCHOOLS, COLLEGES, UNIVERSITIES AND OTHER PRIVATE LEARNING INSTITUTIONS IN TUGUEGARAO CITY THROUGH THE COMMISSION ON HIGHER EDUCATION (CHED) AND THE DEPARTMENT OF EDUCATION (DepEd) TO WAIVE MISCELLANEOUS FEES FOR SCHOOL YEAR 2020-2021

WHEREAS, Article XIV, Section 1 of the Philippine Constitutions provides that *“the state shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all”*;

WHEREAS, for School Year 2020-2021, the Department of Education (DepEd) has officially announced that the conduct of teaching and learning activities shall start on August 24, 2020;



WHEREAS, private higher educational institutions under the guidance and supervision of the Commission on Higher Education (CHED) shall also likewise start their classes in August 2020;

WHEREAS, schools and students shall adjust to the distance learning program or what is known as ONLINE LEARNING where virtual classroom setting shall transpire since physical presence shall not be allowed at this time to prevent the spread of the deadly virus in school campuses;

WHEREAS, in view of the pronouncement of the CHED and the DepEd that face to face classes for School Year 2020-2021 are still not be possible and distance learning/home-based education program shall take place, hence, some school fees may not be charged from the enrollees;

WHEREAS, miscellaneous fees exclusive of the tuition fee include the following: athletics, audio-visual, medical and dental, laboratory, insurance, library and other school facilities which may not be used by the students under a virtual classroom program, hence, the waiving of such miscellaneous fees may be considered by private educational institutions during this crisis situation;

WHEREAS, the CHED Region 02 Director, Ms. Julieta M. Paras, ED.D., CESE, and the DepEd RO2 Director, Ms. Estela L. Cariño, are hereby earnestly requested to consider this resolution the soonest time since the start of classes for SY 2020-2021 is fast approaching.


