CITY RESOLUTION NO. 183-08-2020

RESOLUTION APPROVING BARANGAY ORDINANCE NO. 01-2019 TITLED “AN ORDINANCE ENACTING THE REVENUE CODE OF BARANGAY LEONARDA, TUGUEGARAO CITY, PROVINCE OF CAGAYAN”

WHEREAS, the Local Government Code of 1991 provides that any Local Government Unit including the barangay is vested with the power to enact tax and revenue ordinances for the general welfare of the inhabitants therein subject to the limitations imposed by law;

WHEREAS, Barangay Leonarda has submitted Barangay Ordinance No. 01-2019 titled “*An Ordinance Enacting the Revenue Code of Barangay Leonarda, Tuguegarao City, Province of Cagayan*”;

WHEREAS, the said Revenue Code was enacted by the Sangguniang Barangay during its regular session on January 12, 2019 and subsequently presented the same during a public hearing held on December 20, 2019 at the barangay gymnasium. The minutes of the public hearing and other documents supporting the conduct of the same were submitted to the Joint Committee on Ways and Means and Committee on Barangay Affairs;

WHEREAS, Barangay Leonarda has complied with Department of the Interior and Local Government and Department of Finance Joint Memorandum Circular No. 2019-01 and Bureau of Local Government Finance (BLGF) Memorandum Circular No. 020-2019;

WHEREAS, upon review of the said Ordinance, the committees favorably recommended for the approval of the said Barangay Ordinance.




