WHEREAS, the proposed Sangguniang Kabataaan (SK) Annual Budget of Barangay Caritan Sur for CY 2020 is in order and has complied with the established budgetary requirements as certified by the Local Finance Committee and the same was validated by the Committee on Appropriations.

WHEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Sangguniang Kabataaan (SK) Annual Budget for Calendar Year 2020 of Barangay Caritan Sur in the amount of P291,000.00 prepared in consistent with the approved Annual Barangay Youth Investment Program (ABYIP).


