CITY RESOLUTION NO. 188-08-2020

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE ZONTA CLUB OF CENTRAL TUGUEGARAO AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT

WHEREAS, the referral “*Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with Zonta Club of Central Tuguegarao*” was endorsed to the Eighth City Council;

WHEREAS, the Joint Committee on Rules, Laws and Ethics and Committee on Women and Family, to which the matter was referred, met on July 22, 2020 to discuss the subject referral with the presence of resource persons;

WHEREAS, in response to the theme “Transition, Changes and New Opportunities” of the Biennium 2020-2022, the Zonta Club of Central Tuguegarao aims to have a more comprehensive approach to its focal advocacy;

WHEREAS, as a member of the Zonta International (ZI), the Zonta Club of Central Tuguegarao (ZCCT) partners with local NGOs and LGUs that share their vision;

WHEREAS, the Memorandum of Agreement is pursuant to the Women in Development and Nation Building Act (RA 7192), Magna Carta of Women (RA 9710), Section 16 of the Local Government Code (RA 7160) and the Anti-Violence Against Women and Their Children Act of 2004 (RA 9262);

WHEREAS, the City Council passed City Ordinance No. 30-2017, the Gender and Development Code of Tuguegarao City (GAD Code), “Where it undertakes to enhance the women’s full potential, uplift

their status and improved their quality of life through the enactment of gender-responsive policies; the integration of practices that promote gender quality in both public and private sectors and the eventual eradication of all forms of violence against women and children;

WHEREAS, it has been the clamor of the barangay officials and women volunteers to have a center where all matters, activities and issues related to GAD will be centralized;

WHEREAS, upon review of the subject referral, the joint committees recommended for the adoption and approval of the Memorandum of Agreement and the granting of authority to the City Mayor to sign for and on behalf of the City Government the said Memorandum of Agreement;


WHEREAS, Committee Report No. 057-2020 shall form an integral part of this Resolution.
