**CITY RESOLUTION NO. 189-08-2020**

**RESOLUTION ENCOURAGING THE USE OF DUAL-FLUSH TOILETS IN ALL HOUSEHOLDS, INSTITUTIONS AND BUSINESS ESTABLISHMENTS IN TUGUEGARAO CITY**

**WHEREAS**, Section 16 of the Local Government Code provides that “within their respective territorial jurisdiction, local government units shall enhance the right of the people to a balance ecology”;

**WHEREAS**, Article IV, Section 10 (D) (f) of Republic Act 8755, otherwise known as the Tuguegarao City Charter, also provides that the Sangguniang Panlungsod of Tuguegarao City shall protect the environment and impose appropriate penalties for acts which endanger the environment and burn farming and such other activities which result in pollution, acceleration of eutrophication of rivers and lakes or of ecological imbalance;

**WHEREAS**, it is necessary to strengthen and continuously build up the capability of the City Government to safeguard its environment through the design and implementation of a sustainable and comprehensive conservation and solid waste management and environmental protection program for the benefit and welfare of its inhabitants;

**WHEREAS**, Tuguegarao City has the duty to promote conservation of its natural resources;

**WHEREAS**, the use of dual-flush toilets can effectively reduce the amount of water flushed during use since only one button will be used for liquid waste, while both buttons for solid waste;


**WHEREAS**, the use of dual-flush toilet is encouraged to those who are securing building permits for households, institutions and business establishments in Tuguegarao City.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to encourage the use of dual-flush toilets in all households, institutions and business establishments in Tuguegarao City.
