CITY RESOLUTION NO. 190-08-2020

**RESOLUTION PROVIDING FOR INCENTIVES FOR WORK-FROM-HOME
ARRANGEMENTS IN PRIVATE ENTITIES**

WHEREAS, the prime duty of the government is to serve and protect the people and to promote the general welfare of the community;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that “every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, on March 17, 2020, President Rodrigo Roa Duterte issued Proclamation No. 929 placing the entire Luzon under Enhanced Community Quarantine (ECQ) to contain the spread of COVID-19;

WHEREAS, the Tuguegarao City Government recognizes that COVID-19 is a public health emergency with wide-ranging social, political and economic repercussions, and that responding to the City’s COVID-19 situation is imbued with public interest;

WHEREAS, the Inter-Agency Task Force (IATF) has placed the Province of Cagayan under General Community Quarantine (GCQ) wherein several businesses under the GCQ guidelines cannot still open and operate;

WHEREAS, there is a need to give incentives for Work-From-Home Arrangements in Private Entities considering that business sector was severely affected during the implementation of home quarantine as they have limited access to the buying public and customers;

WHEREAS, the Business Permit and Licensing Office shall issue guidelines to implement this resolution, subject to the approval of the COVID-19 Task Force;

WHEREAS, the Technical Working Group shall compose of the BPLO, City Treasurer's Office, City Budget Office, Tuguegarao City Investment Promotion Center and the City Mayor's Office to determine the proper incentives to be given subject to the resources of the City Government and to further identify the qualified recipients of such incentives;

WHEREAS, a similar incentive be given also to those engaged in lease business and all private banking and financial institutions which complied with the call of the national government for relief of payment of rentals and reduction of interest rates.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, for the City Government of Tuguegarao, to adopt the policy in providing incentives for work-from-home arrangements in private entities subject to the recommendation of the Technical Working Group to the City Mayor.

RESOLVED FURTHER, to furnish a copy of this resolution to the City's Business Permit and Licensing Office (BPLO), for information and proper action.
