CITY RESOLUTION NO. 191-08-2020

RESOLUTION APPROVING BARANGAY ORDINANCE NO. 002-2020 TITLED “AN ORDINANCE ENACTING THE OMNIBUS REVENUE CODE OF BARANGAY ATULAYAN SUR, TUGUEGARAO CITY, PROVINCE OF CAGAYAN”

WHEREAS, the Local Government Code of 1991 provides that any local government unit including the barangay is vested with the power to enact tax and revenue ordinances for the general welfare of the inhabitants therein subject to the limitations imposed by law;

WHEREAS, Barangay Atulayan Sur has submitted Barangay Ordinance No. 002-2020 titled “An Ordinance Enacting the Omnibus Revenue Code of Barangay Atulayan Sur, Tuguegarao City, Province of Cagayan”;

WHEREAS, the Sangguniang Barangay has enacted its Omnibus Revenue Code during its Regular Session on February 8, 2020. A public hearing relative thereto was held at the barangay gymnasium. The minutes of the public hearing and other documents supporting the conduct of the same were submitted to the committee;

WHEREAS, the Omnibus Revenue Code of Barangay Atulayan Sur was found to be in compliance with Department of Interior and Local Government (DILG) and Department of Finance Joint Memorandum Circular No. 2019-01 dated May 17, 2019, Re: Guidelines for the Review, Adjustment, Setting and/or Adoption of Reasonable Regulatory Fees and Charges of Local Government Units, and Bureau of Local Government Finance (BLGF) Memorandum Circular No. 020-2019 dated September 2, 2019, Re: Local Fees and Charges Toolkit on the Review, Setting and/or Adoption of Reasonable Fees and Charges;

WHEREAS, upon review of the said ordinance, the committee favorably recommends for the approval of the “Letter of the Punong Barangay of Atulayan Sur, Hon. Virginia A. Tumaliuan, resubmitting


