WHEREAS, the twin suicide bombings in Jolo, Sulu on August 24, 2020 claimed the lives of eight soldiers, six civilians and a policeman while wounding more than 80 others;

WHEREAS, the first bombing occurred as Philippine Army personnel were assisting in carrying out COVID-19 humanitarian efforts while the second bombing happened at Our Lady of Mount Carmel Cathedral which was previously bombed in 2019 killing at least 20 people;

WHEREAS, **Staff Sergeant Louie Cuarteros** of the 21st Infantry Battalion was among the eight soldiers who were killed in the said bombings;

WHEREAS, Staff Sergeant Louie Cuarteros who hailed from Cataggaman Nuevo, Tuguegarao City served the country for 20 years as an Army soldier under the 21st Infantry Battalion;

WHEREAS, the death of **Staff Sergeant Louie Cuarteros** is a great loss to the nation's quest for peace and stability in Mindanao and in solving the conflict in Jolo, Sulu;

WHEREAS, the people of Tuguegarao and the entire nation are in solidarity with the grieving of the family, relatives and friends of **Staff Sergeant Louie Cuarteros.**


