WHEREAS, the proposed Sangguniang Kabataan (SK) Annual Budget of Barangay Pallua Norte for CY 2020 is in order and has complied with the established budgetary requirements as certified by the Local Finance Committee and the same was validated by the Committee on Appropriations.

WHEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Sangguniang Kabataan (SK) Annual Budget for Calendar Year 2020 of Barangay Pallua Norte in the amount of P333,222.20 prepared in consistent with the approved Annual Barangay Youth Investment Program (ABYIP).


