CITY RESOLUTION NO. 205-08-2020

A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS-RO2 ON THE HEALTH FACILITIES CONTAINER VAN FOR COVID-19 PATIENTS AND PROFESSIONALS AND AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, the Department of Public Works and Highways – Regional Office No. 02 (DPWH-RO2) assists the LGUs for the construction of various medical healthcare facilities and other related facilities for COVID-19 patients and professionals: DPWH Standard One (1) Storey Health Facilities Container Van (Option 1) – 2 Units with 1 Swabbing Booth, to alleviate the daily operational challenges during the crisis;

WHEREAS, Tuguegarao City shall be provided with health facilities container van;

WHEREAS, the DPWH-RO2 shall undertake the preparation of the conceptual plan of the proposed two (2) units of DPWH Standard One (1) Storey Health Facilities Container Van with one (1) swabbing booth, procurement and the corresponding construction management and supervision of the project;

WHEREAS, the funds for this proposed project will be considered out of the appropriation comprehensively released to the DPWH Central Office through the FY 2020 General Appropriations Act;

WHEREAS, the parties agreed that the operation of the said project after its completion shall be undertaken by the Tuguegarao City Government following the necessary health standards and protocols;

WHEREAS, the said health facilities container vans will remain properties of DPWH-RO2 and may be dismantled and removed on site after the pandemic and the structure is no longer necessary;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has indorsed to the Eighth City Council the MOA for approval;

WHEREAS, the Eighth City Council during its 56th Regular Session held on September 15, 2020 deemed it proper, necessary and beneficial to approve the herein indorsement.



RESOLVED FURTHER, to furnish a copy of this resolution to Department of Public Works and Highways (DPWH), Regional Office No. 02, for information and proper action.




