CITY RESOLUTION NO. 206-08-2020

A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) ON THE GRANT OF LOTTO FUND SHARE AND GRANT OF CALAMITY ASSISTANCE, AND AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, the Philippine Charity Sweepstakes Office (PCSO) is the principal government agency to raise and provide funds for health programs, medical assistance and services, and charities of national character through the conduct of sweepstakes, races, nationwide online lottery (“Lotto”), Small Town Lottery (“STL”) and other similar activities;

WHEREAS, the PCSO recognizes the role of LGUs as its partners in raising revenues within their jurisdiction and in turn would like to support LGUs in providing the needed medical and health services to their constituents;

WHEREAS, the PCSO, pursuant to its mandate and aligned with the President’s programs, provides LGUs with a portion of the charity fund generated from the sales of Lotto and STL within their jurisdiction, as share of LGUs to be used by them for their medical and health-related services;

WHEREAS, the PCSO also provides Calamity Assistance to LGUs in times of natural calamities and disasters including those caused by outbreaks, epidemics and pandemics under its Calamity Assistance Program;

WHEREAS, Tuguegarao City is one of the LGUs which shall be provided assistance by PCSO;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has indorsed to the Eighth City Council the MOA for approval;

WHEREAS, the Eighth City Council during its 56th Regular Session held on September 15, 2020 deemed it proper, necessary and beneficial to approve the herein indorsement.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Tuguegarao City Government and the Philippine Charity Sweepstakes Office (PCSO) on the grant of Lotto Fund Share and Grant of Calamity Assistance and authorizing the City Mayor, Hon. Atty. Jefferson P. Soriano to sign for and on behalf the Tuguegarao City Government the said MOA.

RESOLVED FURTHER, to furnish a copy of this resolution to Philippine Charity Sweepstakes Office, for information and proper action.


On joint motion, **CITY RESOLUTION NO. 206-08-2020** was **APPROVED** under suspended rules.


