CITY RESOLUTION NO. 219-08-2020

A RESOLUTION REQUESTING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO PLACE TUGUEGARAO CITY UNDER TOTAL LOCKDOWN ON OCTOBER 9-11, 2020 DUE TO THE ALARMING INCREASE OF COVID-19 LOCAL COMMUNITY TRANSMISSION CASES

WHEREAS, due to the alarming increase of COVID-19 positive cases, Tuguegarao City was reverted back to Modified Enhanced Community Quarantine (MECQ) status with the concurrence of the Regional Inter-Agency Task Force through the recommendation of Cagayan Governor Manuel N. Mamba;

WHEREAS, the MECQ Period shall be for 14 days which commenced last October 3, 2020 and shall continue until October 16, 2020;

WHEREAS, under MECQ status, movement of people will be limited, public transport is prohibited including non-essential economic activities, liquor ban will be imposed again, and talipapas are allowed to operate on certain days only;

WHEREAS, as of October 1, 2020, there have been 78 active cases recorded and 19 barangays affected in Tuguegarao City;

WHEREAS, the city's isolation and quarantine facilities are now full which leaves some positive patients to be on home quarantine;

WHEREAS, the Department of Health had declared that there is already a community transmission in the city as the source of infections of some of the positive cases can no longer be traced;





WHEREAS, in view of such, there is a need for Tuguegarao City to be placed under lockdown status on October 9-11, 2020 (Friday, Saturday and Sunday) to control, restrict and prohibit movements of people to curb the increase of positive cases; and

WHEREAS, during the lock down period, only medical frontliners and those with medical emergency issues shall be allowed to go out from their residences while only drug/pharmaceutical stores shall be allowed to operate.

NOW, therefore, **RESOLVE** as it is hereby **RESOLVED**, to request the City Mayor, Hon. Atty. Jefferson P. Soriano, to place Tuguegarao City under Total Lockdown on October 9-11, 2020 due to the alarming increase of COVID-19 Local Community Transmission Cases.

On motion of Hon. Raymund P. Guzman, duly seconded by Hon. Imogen Claire M. Callangan and with the abstention of Hon. Maila Rosario T. Que, CITY RESOLUTION NO. 219-08-2020 was APPROVED under suspended rules.
