

RESOLUTION ADOPTING AND APPROVING CITY DEVELOPMENT COUNCIL (CDC)
RESOLUTION NO. 07-2020 TITLED "RESOLUTION ENDORSING TO THE 8th TUGUEGARAO
CITY COUNCIL THE REVISED COMPREHENSIVE DEVELOPMENT PLAN (CDP)
CY 2019-2025 TO INCLUDE COVID-19 PROGRAMS, PROJECTS AND ACTIVITIES
AND SPECIAL WEAPON AND TACTICS (SWAT)"

WHEREAS, Section 106 of the Local Government Code of 1991 mandates each local government unit to prepare a comprehensive multi-sectoral development plan to be initiated by its local development council and approved by its sanggunian;

WHEREAS, Section 109 (a)(1) of the Local Government Code of 1991 (RA 7160) mandates the Local Development Council to formulate long-term, medium-term and annual socioeconomic development plans;

WHEREAS, the Comprehensive Development Plan (CDP) CY 2019-2025 was approved by the City Development Council Resolution 02 dated May 20, 2019 and adopted by the 7th City Council in City Resolution No. 099-2019;

WHEREAS, the Comprehensive Development Plan (CDP) sets the city government's strategic direction for the next six (6) years and details its priority sectoral and cross-sectoral programs and projects consistent with the vision of Tuguegarao City;

WHEREAS, there is a need to include COVID-19 Programs, Projects and Activities (PPAs) and Special Weapon and Tactics (SWAT) in the Comprehensive Development Plan (CDP) CY 2019-2025 to address and respond to COVID-19 emergencies, peace and order management, and other services of the local government unit of Tuguegarao City;
