WHEREAS, the Executive-Legislative Agenda (ELA) sets the local government's strategic directions for the next three years and provide an explicit expression of the present administration's goals, objectives, strategic priorities and programs that are consistent with the LGU vision and mission;

WHEREAS, the Tuguegarao City Executive-Legislative Agenda (ELA) CY 2019-2022 was approved by the City Development Council (CDC) in CDC Resolution No. 005 dated October 01, 2019 and adopted by the Eighth City Council in City Resolution No. 204-08-2019 dated October 03, 2019;

WHEREAS, President Rodrigo R. Duterte issued a Declaration of State of Calamity throughout the Philippines for a period of one (1) year, effective September 2020 to September 12, 2021, unless rescinded earlier or extended as circumstances may warrant;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed to the Eighth City Council CDC Resolution No. 08, Series of 2020 for approval;

WHEREAS, the Eighth City Council during its Special Session held on October 08, 2020 deemed it proper and necessary to approve CDC Resolution No. 08-2020.
