**RESOLUTION ADOPTING AND APPROVING CITY DEVELOPMENT COUNCIL (CDC)
 RESOLUTION NO. 09-2020 TITLED "A RESOLUTION ENDORSING TO THE
 8th TUGUEGARAO CITY COUNCIL THE INCLUSION OF COVID-19 PROGRAMS, PROJECTS
 AND ACTIVITIES (PPAs) AND SPECIAL WEAPON AND TACTICS (SWAT) IN THE LOCAL
 DEVELOPMENT INVESTMENT PROGRAM (LDIP) CY 2019-2022"**

WHEREAS, Section 114 (a) of Republic Act No. 7160 or the Local Government Code of 1991 provides that "the policies, programs and projects proposed by the local development council shall be submitted to the sanggunian for appropriate action";

WHEREAS, Section 305 (i) of Republic Act No. 7160 or the Local Government Code of 1991 provides that "local budgets shall operationalize approved local development plans";

WHEREAS, the Local Development Investment Plan (LDIP) is a basic programming document of prioritized programs, projects and activities (PPAs) to be implemented annually within a period of three (3) years for cities and is linked to the budget;

WHEREAS, the Local Development Investment Program (LDIP) CY 2019-2022 was approved by the City Development Council (CDC) in CDC Resolution No. 06 dated October 09, 2019 and adopted by the Eighth City Council in City Resolution No. 233-08-2019 dated October 29, 2019;

WHEREAS, there is a need to include COVID-19 Programs, Projects and Activities (PPAs) and Special Weapon and Tactics (SWAT) in the LDIP CY 2019-2022 to address and respond to the COVID-19 emergencies, peace and order, and other services of the local government unit of Tuguegarao City;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed to the Eighth City Council CDC Resolution No. 09, series of 2020 for approval;


WHEREAS, the Eighth City Council during its Special Session held on October 08, 2020 deemed it proper and necessary to approve CDC Resolution No. 09-2020.
