**RESOLUTION ADOPTING AND APPROVING CITY DEVELOPMENT COUNCIL (CDC)  
 RESOLUTION NO. 10-2020 TITLED "A RESOLUTION ENDORSING TO THE  
 8<sup>th</sup> TUGUEGARAO CITY COUNCIL THE AMENDMENT OF CY 2020 ANNUAL DEVELOPMENT  
 PLAN (ADP) PURSUANT TO THE REVISED COMPREHENSIVE DEVELOPMENT PLAN (CDP)  
 CY 2019-2025, EXECUTIVE-LEGISLATIVE AGENDA (ELA) AND LOCAL DEVELOPMENT  
 INVESTMENT PROGRAM (LDIP) CY 2019-2022 TO INCLUDE SPECIAL WEAPON AND  
 TACTICS (SWAT) AND COVID-19 PROGRAMS, PROJECTS AND ACTIVITIES"**

**WHEREAS**, Section 114 (a) of Republic Act No. 7160 or the Local Government Code of 1991 provides that "the policies, programs and projects proposed by the local development council shall be submitted to the sanggunian for appropriate action";

**WHEREAS**, Section 305 (i) of Republic Act No. 7160 or the Local Government Code of 1991 provides that "local budgets shall operationalize approved local development plans";

**WHEREAS**, the CY 2020 Annual Development Plan (ADP) was approved by the City Development Council in CDC Resolution No. 07 dated October 9, 2019 and adopted by the 8<sup>th</sup> Tuguegarao City Council in City Resolution No. 234-08-2019;

**WHEREAS**, the CY 2020 Annual Development Plan comprises the programs, projects and activities to be funded and carried out in each Calendar Year;

**WHEREAS**, there is a need to include COVID-19 Programs, Projects and Activities (PPAs) and Special Weapon and Tactics (SWAT) in the CY 2020 to address and respond to the COVID-19 emergencies, peace and order, and other services of the local government unit of Tuguegarao City;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed to the Eighth City Council CDC Resolution No. 10, series of 2020 for approval;


