**RESOLUTION ADOPTING AND APPROVING CITY DEVELOPMENT COUNCIL (CDC)
 RESOLUTION NO. 14-2020 TITLED “RESOLUTION ENDORSING TO THE 8th TUGUEGARAO
 CITY COUNCIL THE APPROVAL OF THE TUGUEGARAO CITY CY 2021 LOCAL DISASTER
 RISK REDUCTION AND MANAGEMENT PLAN (LDRRMP) AND CY 2021 LOCAL
 DISASTER RISK REDUCTION AND MANAGEMENT FUND - ANNUAL
 INVESTMENT PROGRAM (LDRRMF - AIP)”**

WHEREAS, Section 12 (c) (6) of the Philippine Disaster Risk Reduction and Management Act of 2010 (RA 10121) mandates that the Local Disaster Risk Reduction and Management Councils (LDRRMCs) of Local Government Units (LGUs) “*formulate and implement a comprehensive and integrated Local Disaster Risk Reduction and Management Plan (LDRRMP) in accordance with the national, regional and provincial framework, and policies on disaster risk reduction in close coordination with the local development councils*”;

WHEREAS, Section 12 (c) (7) of the same act mandates that the Local Disaster Risk Reduction and Management Councils (LDRRMCs) of Local Government Units (LGUs) “*prepare and submit to the local sanggunian through the Local Disaster Risk Reduction and Management Council (LDRRMC) and Local Development Council (LDC) the Annual Local Disaster Risk Reduction and Management Office (LDRRMO) Plan and Budget, the proposed programming of the Local Disaster Risk Reduction and Management Fund (LDRRMF), other dedicated disaster risk reduction and management resources, and other regular funding source/s and budgetary support of the Local Disaster Risk Reduction and Management Council (LDRRMC)/Barangay Disaster Risk Reduction and Management Committees (BDRRMCs)*”;

WHEREAS, the optimal, efficient and timely use of funds is critical in ensuring that the plans in relation to disaster management are implemented and objectives are achieved;

WHEREAS, CDC Resolution No. 14-2020 titled “*Resolution Endorsing to the 8th Tuguegarao City Council the Approval of the Tuguegarao City CY 2021 Local Disaster Risk Reduction and Management*”


