CITY RESOLUTION NO. 231-08-2020

**RESOLUTION EXPRESSING GRATITUDE AND APPRECIATION TO
 THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG)
 SECRETARY, HON. EDUARDO M. AÑO, FOR HIS SUPPORT
 TO TUGUEGARAO CITY DURING THE CRITICAL PERIOD OF MECQ**

WHEREAS, the World Health Organization has declared Corona Virus Disease (COVID-19) as a pandemic and in response thereto, President Rodrigo R. Duterte, through Proclamation No. 922, declared the Philippines under State of Public Health Emergency;

WHEREAS, on October 1, 2020, the surge of cases in Tuguegarao City reached an average of 5-7 cases per day with a total of seventy-eight (78) confirmed cases in nineteen (19) barangays which was thirty-nine percent (39%) of the forty-nine (49) barangays;

WHEREAS, there was a surge in confirmed cases in three (3) barangays, namely: Barangay Centro 09, Barangay Linao West and Barangay Cataggaman Nuevo affecting adjacent barangays;

WHEREAS, in view of the above, Tuguegarao City was placed under MECQ for fourteen (14) days, from October 03, 2020 until October 16, 2020, which was recommended by City Mayor Jefferson P. Soriano, approved by Governor Manuel N. Mamba and concurred by the Cagayan Valley Regional Inter-Agency Task Force on October 01, 2020;

WHEREAS, the Department of the Interior and Local Government has extended support to Tuguegarao City during the critical period of MECQ of Tuguegarao City by providing 112 contract tracers.

NOW, THEREFORE, RESOLVE, as it hereby **RESOLVED**, to express gratitude and appreciation to **THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) SECRETARY, HON. EDUARDO M. AÑO**, for his support to Tuguegarao City by providing 112 contract tracers during the critical period of Modified Enhanced Community Quarantine (MECQ).


