CITY RESOLUTION NO. 239-08-2020

RESOLUTION APPROVING THE REPROGRAMMING OF SAVINGS FROM DONATIONS MADE DURING TYPHOONS TO FUND THE DIFFERENT COVID-19 RELATED PROGRAMS, PROJECTS AND ACTIVITIES (PPAs) AND AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, THE UTILIZATION OF THE SAID SAVINGS TO FUND COVID-RELATED PPAs

WHEREAS, Section 23 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides among other things that *“the local chief executive may, upon authority of the Sanggunian, negotiate and secure financial grants or donations in kind, in support of the basic services or facilities enumerated under Section 17 hereof, from local and foreign assistance agencies without necessity of securing clearance or approval therefor from any department agency, or office of the national government or from any higher local government unit;”*

WHEREAS, the City Accountant issued on August 26, 2020 a Certification on the availability of Savings from the following Donations during typhoons in the amount of Five Million Five Hundred Seventy Thousand Three Hundred Thirty-One Pesos (P5,570,331.00):

1. Theodor E. Stoops	Donations for Typhoon Tisoy Victims	P100,000.00
2. Land Bank of the Philippines	Donations for Typhoon Tisoy Victims	200,000.00
3. Land Bank of the Philippines	Donations for Typhoon Ompong Victims	70,331.00
4. LGU of Makati City	Donations for Typhoon Lawin Victims	200,000.00
5. Office of the President	Donations for people affected by Typhoon Quiel and Ramon	5,000,000.00

WHEREAS, Tuguegarao was placed under under Enhanced Community Quarantine (ECQ) from March 17, 2020 to April 30, 2020, Modified Community Quarantine (MCQ) from May 01, 2020 to June

30, 2020, Modified General Community Quarantine (MGCQ) from July 01, 2020 to August 25, 2020 and General Community Quarantine (GCQ) from September 25, 2020 to October 02, 2020;

WHEREAS, Tuguegarao City was reverted back to Modified Enhanced Community Quarantine (MECQ) from August 26, 2020 to September 04, 2020 and from October 03, 2020 until October 16, 2020 due to the increasing number of confirmed COVID-19 cases;

WHEREAS, the City Government of Tuguegarao has adopted a number of Programs, Projects and Activities (PPAs) to prevent the further spread of COVID-19;

WHEREAS, there is a need to reprogram and authorize the use of Savings from Donations made during typhoons in order to augment the fund intended for COVID-19 related Programs, Projects and Activities (PPAs).


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Reprogramming of Savings from Donations made during typhoons to fund the different COVID-19 related Programs, Projects and Activities (PPAs) and authorizing the City Mayor, Hon. Atty. Jefferson P. Soriano, the utilization of the said Savings to fund COVID-19 related PPAs, to wit:

- a. Procurement of Personal Protective Equipment;
- b. Procurement of equipment, reagents, and kits for COVID-19 testing;
- c. Procurement of medicines and vitamins;
- d. Procurement of hospital equipment and supplies;
- e. Procurement of disinfectants, sprayers, disinfection tents, and other disinfecting supplies and misting equipment;
- f. Food, transportation (including fuel) and accommodation expenses of medical personnel and other LGU personnel directly involved in the implementation of COVID-19 related PPAs;
- g. Procurement, maintenance, repair of ambulance, medical transport vehicle and emergency response vehicle;
- h. Food assistance and other relief goods for affected households;
- i. Expenses for the construction, repair, lease or rental of additional space or building to accommodate COVID-19 patients and persons under monitoring/investigation;
- j. Expenses for the operation of stand-alone/mobile testing laboratory;
- k. Expenses for the purchase or rental of tents or spaces for temporary shelters of the homeless;
- l. Expenses for training of personnel in the conduct of COVID-19 testing and other related trainings; and,
- m. Other necessary COVID-19 related PPAs and expenses


On joint motion, **CITY RESOLUTION NO. 239-08-2020** was **APPROVED** under suspended rules.
