CITY RESOLUTION NO. 248-08-2020

RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF FOREIGN AFFAIRS

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed to the Eighth City Council the Memorandum of Agreement (MOA) between the Tuguegarao City Government and Department of Foreign Affairs requesting for an authority to enter into and sign the said MOA for and on behalf of the Tuguegarao City Government;

WHEREAS, the Tuguegarao City Government is the legitimate owner of the building located at the Tuguegarao City Hall Compound, Tuguegarao City;

WHEREAS, the Department of Foreign Affairs, in its desire to bring the government services closer to the people, has expressed to partner with the City Government to ensure the public of a more efficient and convenient delivery of passport and other consular services;

WHEREAS, the Department of Foreign Affairs has been occupying a portion of the Tuguegarao City Hall building and has decided to renew the MOA;

WHEREAS, the terms and conditions of the subject MOA are not contrary to law, public policy and public order, and are beneficial to both parties.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, authorize the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Affairs represented by Undersecretary (Civilian Security and Consular Concerns) Brigido J. Dulay, for the use of the building as office space located at the Tuguegarao City Hall Compound, Tuguegarao City, Cagayan.

RESOLVED FURTHER, that the term shall be for a period of ten (10) years as stipulated in the Memorandum of Agreement.
