 IN TUGUEGARAO CITY TO WEAR FACE MASK ONLY WHILE DRIVING  
 IN VIEW OF THE HOT WEATHER IN TUGUEGARAO CITY**

**WHEREAS**, Tuguegarao City in Cagayan Province is considered to be the hottest area in the Philippines due to scorching heat during dry season;

**WHEREAS**, it is in Tuguegarao City where the country's highest temperature was recorded in 1912 and 1969;

**WHEREAS**, Tuguegarao City is currently under Modified General Community Quarantine (MGCQ) wherein permissive socioeconomic activities are allowed with minimum public health standards;

**WHEREAS**, under MGCQ, the operation of tricycles was expanded by virtue of Ordinance No. 45-08-2020 to address the need of the riding public considering the influx of people to the City, being the Regional Center;

**WHEREAS**, the Eighth City Council has enacted Ordinance No. 61-08-2020 mandating the Wearing of Protective Face Masks and Face Shields in Tuguegarao City and Providing Penalties for Violations Thereof;

**WHEREAS**, transport systems are allowed to operate by Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID) in accordance with the guidelines issued by the Department of Transportation and one of these is the wearing of face mask and face shield by passengers and drivers;

**WHEREAS**, tricycle drivers for hire/private have expressed their discomfort and inconvenience wearing both face mask and face shield at the same time while driving because of the scorching heat that can cause moist in the face shield and difficulty in catching their breath;


**WHEREAS**, in no case shall the tricycle driver not wear/use face shield when not driving. The exemption of not wearing face shield applies only to tricycle drivers (for hire/private) while driving. While not driving or in public places, the tricycle drivers are obliged to wear face shield.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to request the Chair of Region 02 Task Force (RTF) on COVID-19, Director Gante Balao, through the Tuguegarao City Mayor, Hon. Atty. Jefferson P. Soriano, to Consider Allowing Tricycle Drivers in Tuguegarao City to Wear Face Mask only while driving in view of the hot weather in Tuguegarao City.


On joint motion, **CITY RESOLUTION NO. 252-08-2020** was **APPROVED** under suspended rules.
