CITY RESOLUTION NO. 258-08-2020

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE OZAMIS CITY GOVERNMENT IN RELATION WITH THEIR MONETARY DONATION IN THE AMOUNT OF SEVEN HUNDRED FIFTY THOUSAND PESOS P750,000.00 AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN AND CONCUR FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO CITY THE SAID MOA


WHEREAS, Article X, Section 13 of the Philippine Constitution provides that local government units may group themselves, consolidate or coordinate their efforts, services and resources for purposes commonly beneficial to them in accordance with law;

WHEREAS, pursuant to the herein provision, the Local Government Unit of Ozamis City took the initiative to give monetary donation to Tuguegarao City Government in response to its goal of maximizing its assistance to its constituents who were struck by typhoon Ulysses;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, indorsed to the Eighth City Council the said Memorandum of Agreement (MOA) and requested for an authority to sign for and on behalf of the Tuguegarao City Government the said MOA;

WHEREAS, the Eighth City Council during its 66th Regular Session held on December 3, 2020 found the terms and conditions of the Memorandum of Agreement to be in order, with merit and beneficial to the constituents of the City;

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the Memorandum of Agreement (MOA) between the Tuguegarao City Government and the Ozamis City Government in relation with their monetary donation in the amount of Seven Hundred Fifty Thousand Pesos P750,000.00 and granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign and concur for and on behalf of the Tuguegarao City Government the said MOA.
